ARTICLES OF INCORPORATION

WE, THE UNDERSIGNED, being three or more natural persons of full age, at least two-thirds are citizens of the United States, or of its territories or possessions, do hereby voluntarily associate ourselves for the purposes of forming a private corporation under the laws of the State of Idaho.

I

The name of the proposed corporation is HEIGHTS, INC.

II

The purposes of the corporation are: to engage in the management of business corporations, associations, partnerships, entities, proprietorships and other organizations of every kind; to purchase, or otherwise, acquire, own, hold, lease, sell, exchange, assign, transfer, mortgage, pledge or otherwise dispose of, to guarantee and to invest, trade and deal in and with personal property of every class and description; to purchase or otherwise acquire, own hold, lease, sell, exchange, assign, transfer, mortgage or otherwise dispose of, and to invest, trade, and deal in and with real property and any and all interests therein; to enter into any kind of contract or agreement, cooperative or profit-sharing plan with its officers or employees that the corporation may deem advantageous or expedient or otherwise to reward or pay such persons for their services as the directors may deem fit; to purchase, lease or to otherwise acquire, in whole or in part, the business, goodwill, rights, franchises and property of every kind, and to undertake the whole or any part of the assets or liabilities of any person, firm, association or corporation engaged in or authorized to conduct any business similar to any business authorized to be conducted by this corporation, or owing property necessary or suitable for its purposes, and to pay for the same in cash, in the stocks or bonds

of this company, or otherwise; to hold or in any manner dispose of the whole or any part of the business or property so acquired, and to exercise all the powers necessary or incidental to the conduct of such business.

To lend money and to negotiate and make loans, either on its own account or as agent or broker for others; to borrow money, to issue bonds, debentures, notes and other obligations of this corporation from time to time, for any of the objects or purposes of this corporation, and to mortgage, pledge, hypothecate, and/or convey in trust, any or all of its property to secure the payment thereof; to discount and negotiate promissory notes, drafts bills of exchange, and other evidences of debt, and to collect for others money due them on notes, check, drafts, bills of exchange, commercial paper and other evidences of indebtedness; to enter into make, perform, and carry out contracts of every kind and for any lawful purpose, without limit as to amount, with any person, firm, association, corporation, municipality, state, or government, or any subdivision, district or department thereof; to acquire, and pay for in cash, shares of stock, bonds or notes of this corporation or otherwise, the assets including the goodwill of any person, firm, association or corporation, and to undertake or assume the whole or any part of the obligations, or liabilities thereof; to engage in and conduct any and all kinds of manufacturing business; to do any and all such other acts, things, business or businesses in any manner connected with or necessary, incidental, convenient or auxiliary to any of the objects hereinbefore enumerated, or calculated directly or indirectly, to promote the interest of the corporation; and in carrying on its purposes, or for the purpose of attaining or furthering any of its business, to do any and all acts and things, and to exercise any and all other powers, which a co-partner

or natural person could do or exercise, and which now or hereafter
any
may be authorized by law, and in/part of the world; the several
clauses contained in this statement of purposes shall be construed
as both purposes and powers, and the statements contained in each
clause shall in nowise limited or restricted, by reference to, or
inference from, the terms of any other clause, but shall be regarded
as independent purposes and powers; and no recitation, expression
or declaration of specific or special powers or purposes herein
enumerated shall be deemed to be exclusive; but it is hereby
expressly declared that all other powers not inconsistent herewith
are hereby included.

The duration of the corporation is perpetual.

The total authorized number of par value shares is
