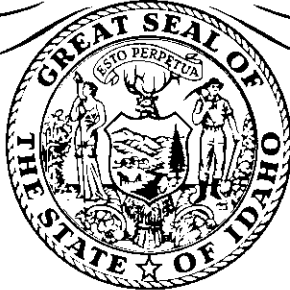


That said corporation has issued shares since the filing of its Articles of Incorporation with the Secretary of State.




