Know all Men by These Presents:

That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the State of Idaho.

And we hereby Certify:

FIRST. That the name of said Corporation is Cherry Grove
Canal Company (Limited)

SECOND. That the purposes for which it is formed are to own control and
conduct a general business of irrigation, canal
and water system, in Teton Valley, Fremont County
Idaho, and to own use and control such real and
personal property as may be necessary for carrying
on said business

THIRD. That the place where its principal business is to be transacted shall be Chapin
Fremont County State of Idaho

FOURTH. That the term for which it is to exist is Fifty years
from and after the date of its incorporation.

FIFTH. That the number of its Directors shall be five, and that the
