ARTICLES OF INCORPORATION
OF
THE RATHDRUM BIBLE CHURCH, INCORPORATED

We, the undersigned, over twenty-one years of age and citizens of the State of Idaho and the USA, desiring to form a non-profit religious corporation pursuant to the provision of chapter three of the Corporation Laws of the State of Idaho, 1986, do hereby certify as follows:

ARTICLE I

The primary purpose for which this church exists is to glorify God through obedience to the Great Commission of our Lord Jesus Christ by engaging in the ministries of evangelism and edification. These ministries shall include, but will not be limited to, regular meetings for worship, praise, Bible Study and fellowship; support of home and foreign missions; Sunday Schools and other regular children's ministries; a full-time Christian Day School; and such other services as may be deemed valuable and advisable by the body.
