Know all Men by these Presents, That we B. F. Vreeland, W. T. Perkins and F. L Grant residents of the State of Colorado, have associated ourselves together as a corporation under the name and style of The Western Lumber & Pole Company for the purpose of becoming a body corporate and politic under and by virtue of the laws of the State of Colorado, and in accordance with the provisions of the laws of said State, we do hereby make, execute and acknowledge in duplicate this certificate in writing of our intention so to become a body corporate, under and by virtue of said laws.

FIRST. The corporate name and style of our said corporation shall be The Western Lumber & Pole Company

The object for which our said Corporation is formed and incorporated shall be to acquire, hold, improve, lease, encumber, exchange or sell timber, farming, ranch or other lands and the products thereof; to purchase, acquire, build, contract, maintain and operate plants, mills and works for the development of such lands and for the handling, preparing and rendering commercially available of the various products thereof; also to purchase, construct or do everything which it may be found necessary or desirable in order to properly handle or facilitate the getting to or placing upon the market of such products, and to acquire by every means known to the law property, real, personal, or mixed, which may be deemed expedient, useful, necessary or desirable in carrying out the objects for which this corporation is formed, and to sell or in any manner dispose of such property so acquired as from time to time may be found expedient or desirable;

also to manufacture, buy, sell, exchange, handle on commission or in any other manner to deal or to traffic in timber, lumber, wood, lath, shingles, poles, posts or kindred products

or any of the various products manufactured from wood; also coal; also cements, lime, plasters and all forms of building materials and products and to handle any and all material usually kept or handled by lumber dealers; also feed

also to engage in, acquire, purchase, conduct and carry on a store or stores for the handling of all kinds of goods, wares and merchandise at wholesale or retail or both;

also to carry on the business of erecting buildings of every kind, manner and structure, either as a contractor or otherwise.

Any and all of above objects, purposes or business to be carried on or transacted outside of as well as within the state of Colorado.

THIRD. The capital stock of our said corporation is one hundred thousand dollars to be divided into one thousand shares of one hundred dollars for each share, and said stock shall be non-assessable.

FOURTH. Our said corporation is to exist for the term of twenty years.

FIFTH. The affairs and management of our said corporation is to be under the control of three directors and B F Vreeland, I A Vreeland and F L Grant, are hereby selected to act as said directors and to manage the affairs and concerns of said corporation and until their successors are elected or appointed

SIXTH. The operations of our said corporation will be carried on in the County of City and County of Denver in the State of Colorado but may be extended into any county or counties in said state, or outside thereof, as in the judgment of the board of directors its business or interests

may require and the principal place and business office of said corporation shall be located in the City and County of Denver and State of Colorado aforesaid.

SEVENTH. The Stockholders shall have power to make such prudential by-laws as they may deem proper for the management of the affairs of this corporation according to the statute in such case made and provided, and amend the same as they shall deem necessary.
