MEMORANDUM OF AGREEMENT REGARDING CENTO VILLAGE, LLC

THIS AGREEMENT is made this 1st day of May, 2016, between RICHARD B. GIESLER ("Giesler" herein), CENTO VILLAGE, LLC ("the Company" herein), and J. FRANCIS FLORENCE, ("Florence" herein).

WHEREAS, the Company is an Idaho limited liability company in which Giesler and Florence in the past have been Members; and

WHEREAS, the parties wish to memorialize Florence's status with the Company.

NOW, THEREFORE, for valuable consideration received, the parties hereby agree as follows:

- 4. This Agreement shall be binding upon and shall benefit the parties hereto and their heirs, successors and assigns.
