STATEMENT OF DOMESTICATION

K DEVELOPMENT, INC.

RECITALS

WHEREAS, the Corporation is a Corporation duly organized under the laws of the State of Montana.

WHEREAS, the Corporation wishes to change its domicile and entity jurisdiction from Montana to Idaho by domestication on the terms set forth more fully in the Plan of Domestication;

WHEREAS, domestication of a Corporation to Idaho is permitted by Idaho Code Title 30, Chapter 22; and

WHEREAS, the Shareholders and Directors in the Corporation, have approved the Plan of Domestication and approve this Statement of Domestication.

STATEMENT

NOW THEREFORE, the Corporation agrees, as follows:

- 1. Conversion and Domestication. Upon filing, the Corporation shall convert from an Montana Corporation to an Idaho Corporation by domesticating to Idaho pursuant to Idaho Code § 30-22-502. Following domestication the Corporation shall be governed by the laws of the State of Idaho. The change in jurisdiction of the Corporation to Idaho shall herein be referred to as the "Domestication."
- 2. Effective Date. The Domestication shall be effective upon (a) the filing of a Statement of Domestication with the Secretary of State of the State of Idaho; (b) the filing of Articles of Organization for K Development, Inc. with the Idaho Secretary of State; and (c) the filing of dissolution with the Secretary of State of the Montana, which filings shall be made as soon as practicable. The time of such effectiveness shall herein be referred to as the "Effective Date."
- 3. *Interest Holders*. On the Effective Date, each share in the Montana Corporation shall be the same ownership interest in the Idaho Corporation and correspond to one share in the Idaho Corporation (1:1).
- 4. *Approval.* The Plan of Domestication and this Statement of Domestication have been approved by the shareholders of the Corporation and the Directors of the Corporation in accordance with the laws of the State of Montana and Idaho.
