

APPLICATION FOR CERTIFICATE OF AUTHORITY

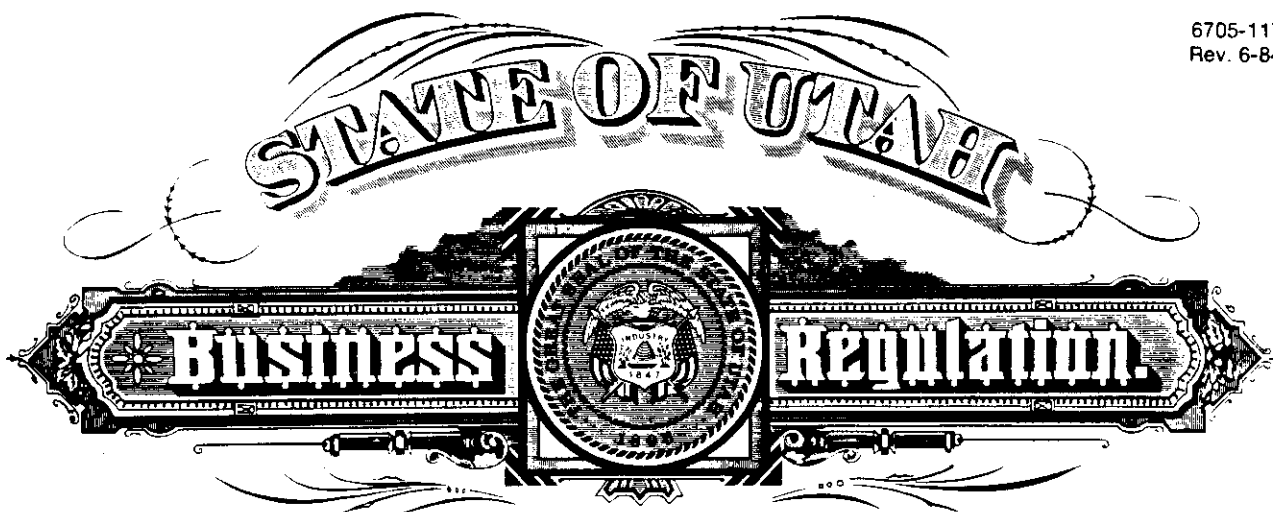

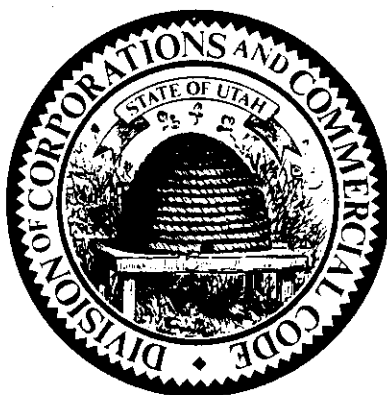
