AND WE HEREBY CERTIFY:

FIRST.

The name of this Corporation shall be "The Saint Anthony and National Park Railway Company", Limited.

SECOND.

The purpose for which said Corporation is formed is the construction and maintenance of a railway. Said railway of standard guage, constructed and equipped in such a manner and with such rolling stock and appliances as are fitted and calculated to enable said railway to carry freight, passengers, mail and express, and to render all services usually rendered by the ordinary modern/railway. And said Corporation to have all the powers necessary to carry out its said purpose and especially all the powers expressly given to railway Corporations as set out in Section 2666 of the Revised Statutes of the State of Idaho, together with the laws amendatory thereof and supplemental thereto, which section and laws are hereby referred to and made part hereof in stating the purposes of this Corporation.
