ARTICLES OF INCORPORATION

The undersigned, acting as Incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE ONE  
NAME OF CORPORATION

The name of the corporation shall be "KIDCO, LTD."

ARTICLE TWO  
PERIOD OF DURATION

The period of duration of the corporation shall be perpetual.

ARTICLE THREE  
CORPORATE PURPOSES
