Advocating for systemic change in the healthcare system to improve practices related to the prescription and management of antidepressant medications, with a focus on patient safety, informed decision-making, and minimizing harm.

Supporting individuals affected by antidepressant use, including those currently using, tapering, or discontinuing antidepressant medications, by offering resources, community support, and educational programs to facilitate safe and informed treatment decisions.

Conducting and promoting research that advances understanding of antidepressant medications, their long-term effects, and best practices for safe and effective use, tapering, and withdrawal.

The organization will also engage in other lawful activities that support these primary objectives, including hosting workshops, publishing research and educational materials, and collaborating with relevant entities to advance these causes.
