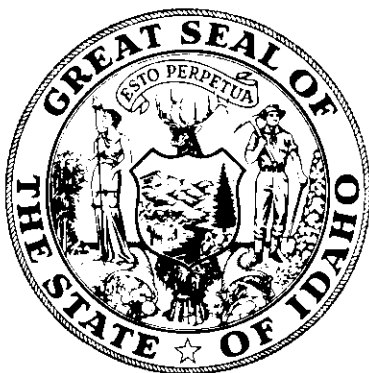

ARTICLES OF INCORPORATION

OF

WESTERN SIGN AND GRAPHICS, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of this corporation is WESTERN SIGN AND GRAPHICS, INC.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose or purposes for which the corporation is organized are: to carry on any and all lawful business or businesses for which a corporation may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 10,000 with no par value.

ARTICLE V

There are no provisions denying preemptive rights.

ARTICLE VI

The address of the initial registered office of the corporation is 8190 Overland Road, Boise, Idaho 83709, and the name of its initial registered agent at such address is Duane Cutler.

ARTICLE VII

meeting of the shareholders, or until their successors are elected, are:






