and as such are subject to the rights, privileges and limitations granted to Non-Profit Cooperative
Associations, as provided in Chapter 10, Title 29, Idaho Code, Annotated.

ARTICLES OF INCORPORATION

IDAHO ASSOCIATION OF SOIL CONSERVATION DISTRICTS, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being natural persons of full age and bona fide residents of the State of Idaho, hereby voluntarily associate ourselves together for the purpose of forming a non-profit corporation under the provisions of Chapter 10, Title 30, Idaho Code, and the laws of the State of Idaho, and the Acts amendatory and supplemental thereto, and we do hereby certify and declare as follows, viz:

ARTICLE I

That the name of the corporation shall be IDAHO ASSOCIATION OF SOIL CONSERVATION DISTRICTS, INC.

ARTICLE II

That the purposes for which this corporation is formed are as follows:

1. To promote, foster, sponsor and encourage interest and cooperation in conserving the soil of the land; to publish or have published magazines, books, leaflets and other printed matter for general circulation intended to promote, incite, encourage and foster interest and cooperation in soil conservation, and to solicit advertising to defray the cost of such publications.
2. To sue and be sued, appear, complain and defend in any court of law or equity or before any board, commission or tribunal.

3. To have and use a corporate seal which may be altered at pleasure.

4. To receive, acquire, hold, purchase, dispose of, convey, mortgage and/or lease, real and personal property; to dispose of, sell, lease assign, transfer, mortgage and/or convey any rights, privileges, franchises, real or personal property of the corporation other than its franchise of being a corporation, and to acquire, purchase, guarantee, hold, mortgage, own, vote, sell, pledge and/or otherwise dispose of and deal in shares, bonds, securities and debentures and other evidences of indebtedness of other corporations, domestic or foreign.

5. To appoint such officers, employees and agents as the business of the corporation may require and to allow them compensation.

6. To make By-Laws not inconsistent with any existing law for the management of its business and property, and the regulation and conduct of its affairs.

7. To issue certificates of membership and admit members as provided by the By-Laws.

8. To enter into contracts or obligations of any type or kind essential, necessary or proper to the transaction of its ordinary affairs, or for the purposes of the corporation.

9. To do all acts which are necessary and expedient to accomplish its stated purposes.

ARTICLE III

That the existence of this corporation is to be perpetual.

ARTICLE IV

That the principal and registered office for the transaction of the business of this corporation is to be located at Lewiston, County of Nez Perce, Idaho.

ARTICLE V

That the names and addresses of the persons who are to act in the capacity of directors until the selection of their successors are:

all of said persons being citizens of the United States of America.
The number of persons named above shall constitute the number of directors of the corporation until changed by an amendment to the By-Laws increasing or decreasing the number of directors as may be desired.

ARTICLE VI

That the membership of the corporation shall consist of the signatories to these Articles of Incorporation and such other persons as may from time to time be elected to the membership of the corporation by the affirmative vote of a majority of the Board of Directors and in compliance with the By-Laws of the corporation to be adopted. Provided, however, that the By-Laws may provide for automatic expiration of and re-election to membership.

A certificate of membership shall be issued to each member of the corporation. Said certificates shall not be assignable nor can they be sold or transferred in any manner.
