I, the undersigned, acting as incorporator of a corporation under the Idaho Professional Service Corporation Act, adopt the following Articles of Incorporation:

Ι.

The name of the Professional Service Corporation is JOHN M. AYERS, JR., M.D., P.A.

II.

The period of its duration is perpetual.

III.

The purpose or purposes for which this Professional Service Corporation is organized is to engage in the practice of medicine; to examine; to x-ray; and to operate or to prescribe for any disease, pain, injury, deformity, or physical condition affecting a human person; and for the transaction of any or all lawful business for which a Professional Service Corporation may be incorporated pursuant to the provisions of the Idaho Professional Service Corporation Act, Chapter 13, Title 30, Idaho Code, including investing its funds in real estate, mortgages, stocks, bonds or any other type of investments, or to own real or personal property necessary for the rendering of professional services.

IV.

The aggregate number of shares which the corporation shall have the authority to issue is FIVE THOUSAND (5,000) shares, all of one class, no par value.

The address of the initial registered office of the corporation, and the initial agent at such address, is JOHN M. AYERS, JR., M.D., 129 West 3rd Street, Moscow, Idaho 83843. Said person is duly licensed by the State of Idaho to practice medicine.
