

ARTICLES OF INCORPORATION
OF
CONCEPTS UNLIMITED, INC.

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, being a natural person of legal age, and acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST:

The name of the corporation is CONCEPTS UNLIMITED, INC.

SECOND:

The period of its duration is perpetual.

THIRD:

The purpose for which the corporation is organized is transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH:

The aggregate number of shares which the corporation shall have authority to issue is One Hundred Thousand (100,000) with no par value. There shall be one class of shares, all of which shall be common shares.

FIFTH:

The address of the initial registered office of the corporation is Sterling Route Box 8, Aberdeen, Idaho, and the name of the initial registered agent at such address is Winford L. Jones.


