SINCE TABLE UNDER STATE ON THE D. of the age of eighteen years, or more, desirous of forming a corporation under the laws of the State of Idams, does hereby adopt the following Articles of Incorporation:

ARTICLE I.

RECEIVED

The name of the corporation shall be W-W TIMBER SERVICES, INCSEC. OF STATE

ARTICLE II.

The corporation shall have perpetual existence.

ARTICLE III.

The purpose of the corporation is conduct timber harvesting operations, and further to engage in all forms and any such activity pertaining thereto not forbidden to corporations by the Constitution, statutes, or common law of the State of Idaho.

ARTICLE IV.

- 1. The capital stock of this corporation shall be \$50,000.00 consisting of 5,000 shares of common stock at a par value of \$10.00 per share. Capital stock my be issued by the corporation from time to time for such consideration, including (without limitation) labor, services, money, or property, as may be fixed by resolution of the Board of Directors from time to time.
- 2. The shareholders of this corporation shall not be entitled to preemptive rights to subscribe for or purchase any part of new or additional issues of stock or securities convertible into stock of any class whatsoever.

ARTICLE V.

This corporation shall not commence business until consideration of the value of at least Five Hundred Dollars (\$500.00) has been received for the issuance of shares.

ARTICLE VI.

The address of the initial registered office of the corporation is:

ARTICLE VII.

At each election for directors every shareholder entitled to vote at such election shall have the right to vote, in person or by proxy, the number of shares owned by him. No cumulative voting for directors shall be permitted.

ARTICLE VIII.

The number of directors of this corporation shall be such number, not less than three (3) except where all shares are owned of record by fewer than three (3) shareholders, in which case the number of directors shall not be less than the number of such shareholders and such number of directors shall be determined from time to time by the shareholders of the corporation. The names and post office addresses of the first directors, who will manage the affairs of the corporation from the time of its organization until their successors are elected and qualified at the first annual meeting are as follows:
