ARTICLES OF INCORPORATION of

Christian D. Brown, a Professional Corporation

ARTICLE I NAME

The name of the Corporation is Christian D. Brown, a Professional Corporation

ARTICLE II DURATION

The Corporation shall have perpetual existence.

ARTICLE III PURPOSE

The Corporation is organized as a professional corporation pursuant to the provisions of chapter 13 of title 30 of the Idaho Code for the following purpose:

- 1. Practice of Law.
- 2. In order to further the practice of law, to carry on any other business in connection with the foregoing, subject to the limitations on other business imposed by the provisions of chapter 13 of title 30 of the Idaho Code.

ARTICLE IV CAPITAL STOCK

The Corporation is authorized to issue 100,000 shares of no-par value common stock, which shall be designated "Common Shares."

ARTICLE V SHAREHOLDER, OFFICER and DIRECTOR LIMITATIONS

Pursuant to the provisions of chapter 13 of title 30 of the Idaho Code, only duly licensed attorneys in good standing in the State of Idaho may be shareholders in the corporation. If any officer, shareholder, agent or employee of this corporation who has been rendering professional service to the public becomes legally disqualified to render such professional services within Idaho or accepts employment that, pursuant to existing law, places restrictions or

limitations upon his continued rendering of such professional services, he shall sever all employment with, and financial interests in, this corporation forthwith. No person may be simultaneously an officer, director, or shareholder of more than one (1) professional corporation.

ARTICLE VI PREEMPTIVE RIGHTS and LIMITATIONS ON TRANSFER OF SHARES

Every shareholder, upon the sale for cash of any additional stock of the Corporation of the same kind, class, or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price at which it is offered to others.

No shareholder of this corporation may sell or transfer his shares in this corporation except to another individual who is eligible to be a shareholder of this corporation, and such sale or transfer may be made only after the same shall have been approved, at a stockholders' meeting specially called for such purposes, by such proportion, not less than a majority, of the outstanding stock as may be provided by these articles or in the by-laws.

ARTICLE VII INITIAL BOARD OF DIRECTORS

No person who is not a shareholder may serve as a director of this corporation. The Corporation shall have I director initially. The number of directors may be increased or diminished from time to time by the Bylaws, but shall never be fewer than one (I). The following initial director shall serve as director until the first annual meeting of shareholders or until their successors be elected and qualify:
