## ARTICLES OF AMENDMENT to the ARTICLES OF INCORPORATION of



# AMERICAN FALLS SCHOOL DISTRICT NO. 381 EDUCATION FOUNDATION INC.

Pursuant to the provisions of Section 30-327 of the Idaho Non-Profit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is AMERICAN FALLS SCHOOL DISTRICT NO. 381 EDUCATION FOUNDATION, INC.

SECOND: The following amendments of the Articles of Incorporation were adopted by the members of the Board of Directors of the corporation on March 11, 1991, in the manner prescribed by the Idaho Non-Profit Corporation Act:

## A. Article VI previously read:

#### **ARTICLE VI**

This Corporation is not a church and the management of its affairs is not vested in its members pursuant to Section 30-314(c) of the Idaho Code.

That article VI be amended to read:

#### ARTICLE VI

This Corporation is not a church and the management of its affairs is not vested in its members pursuant to Section 30-314(c) of the Idaho Code. The management of its affairs is vested in its Board of Directors.

## B. Article X previously read:

#### ARTICLE X

The power to make, alter, amend or repeal the bylaws of this Corporation shall be vested in its Board of Directors with the prior written approval of the Board of Trustees of School District No. 381, and the Bylaws may contain any provision of the regulation and management of the affairs of this Corporation not inconsistent with these Articles of Incorporation and the laws of the State of Idaho.

That Article X be amended to read:

#### ARTICLE X

The power to make, alter, amend or repeal the bylaws of his Corporation shall be vested in its Board of Directors and the Bylaws may contain any provision of the regulation and management of the affairs of this Corporation not inconsistent with these Articles of Incorporation and the laws of the State of Idaho.

### C. Article XI previously read:

#### **ARTICLE XI**

The power to amend these articles of incorporation is vested in the board of directors of the corporation as set out in the bylaws.

That article be amended to read:

#### **ARTICLE XI**

The power to amend these Articles of Incorporation is vested in the members of the corporation. A majority of the votes of the members present at such meeting and/or voting by proxy is needed to amend the Articles.

D. Article XII should be added to the Articles of Incorporation to read::

#### **ARTICLE XII**

This nonprofit corporation has been formed by individuals, in their private capacities, to promote and provide for the purposes and powers herein enumerated. Though formed for the benefit of School District No. 381, such School District does not control such corporation.
