CERTIFICATE OF AMENIMENT OF ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

That at the regular annual meeting of the stock-holders of CALLAHAN ZINC-LEAD COMPANY, an Arizona corporation, duly called for Monday, April 8, 1957, at 12 o'clock noon, and held, pursuant to said notice and adjournment, at Room 910 Valley National Building, Tucson, Arizona, Article III of the Articles of Incorporation of said corporation was, by affirmative vote of a majority of the issued and outstanding shares of stock of said corporation, amended to read as follows:

"ARTICLE III

The amount of the authorized capital stock of the Corporation is Five Million Dollars, divided into Five Million Shares of the par value of One Dollar each which shall be paid in, at such time or times as the Board of Directors may designate, in money or property received or for labor done, and all shares of the capital stock when issued in exchange for property received or labor done shall thereupon and thereby become and be full-paid the same as if paid for in money at par and shall be non-assessable forever, and the judgment of the Board of Directors as to the value of any such property received or labor done for which any shares shall be so issued shall be conclusive."
