OF
CERTIFICATE OF INCORPORATION

NYTCO Services, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware, DOES HEREBY CERTIFY:

FIRST: That by written consent of the Board of Directors of NYTCO Services, Inc. resolutions were duly adopted setting forth a proposed amendment to the Certificate of Incorporation of said corporation, declaring said amendment to be advisable and calling a meeting of the stockholders of said corporation for consideration thereof. The resolution setting forth the proposed amendment is as follows:

RESOLVED, That the corporation's Certificate of Incorporation be amended effective July 1, 1977 to read as follows:

"The name of the corporation shall be Collateral Control Corporation"

SECOND: That thereafter, pursuant to the resolution of its Board of Directors, the stockholders of the corporation by written consent in lieu of a meeting in accordance with section 228 of the General Corporation Law of the State of Delaware, voted the necessary number of shares as required by statute in favor of the amendment.

THIRD: That said amendment was duly adopted in accordance with the provisions of section 242 of the General Corporation Law of the State of Delaware.
