

ARTICLES OF AMENDMENT OF RELCO, INC.

The undersigned Directors, acting as Directors and under authority of law regarding Relco, Inc., under the provisions of Title 30, Idaho Code, hereby certify that a meeting was had, and a resolution was effected by the Board of Directors of the above named Corporation on the 7th day of December, 1995, which set forth a proposed amendment to the Articles of Incorporation of Relco, Inc. Subsequent thereto, a special meeting of the Shareholders of Relco, Inc., was held on the 7th day of December, 1995, and the Shareholders present at said meeting constituted a quorum thereof. The resolution of the Board of Directors for amendment of the Articles of Incorporation of Relco, Inc., was presented to the Shareholders of said Corporation, and a vote of the Shareholders was taken at said meeting. The Shareholders voted unanimously in favor of amending the Articles of Incorporation of Relco, Inc., to change the name of said corporation to that of Dean Bonesteel, Inc. The Shareholders further voted unanimously in favor of amending the Articles to change the purpose and number of Directors of said corporation. The change of purpose is to allow for the sale of insurance and to amend the number for Directors to not more than TWO (2). The undersigned further certify that the following was adopted by the Board of Directors of the Corporation, and was adopted by the Board of Directors of the Corporation and was unanimously voted in favor of by the Shareholders of the Corporation as being Amendments to the Articles of Incorporation of Relco, Inc., and as follows:

The date of the adoption was the 7th day of December, 1995 and the total number of shares outstanding being of a single class is 20,000 the same being voted unanimously for the foregoing Articles of Amendmend.
