ARTICLES OF INCORPORATION

OF

CHEMICAL DISTRIBUTORS, INC.

The undersigned natural person over the age of 18 years, acting as Incorporator of a corporation under the Oregon Business Corporation Act, hereby adopts the following Articles of Incorporation:

#### ARTICLE I

The name of this corporation is CHEMICAL DISTRIBU-TORS, INC., and its duration shall be perpetual.

#### ARTICLE II

The purposes for which the corporation is organized are to engage in any lawful activity for which corporations may be organized under ORS Chapter 57.

#### ARTICLE III

The aggregate number of shares which the corporation shall have authority to issue is Five Hundred (500) shares having no par value.

#### ARTICLE IV

The address of the initial registered office of the corporation in the State of Oregon is Suite 1440, 200 Market Building, Portland, Oregon 97201, and the name of its initial reistered agent at such address is David B. Avison.

#### ARTICLE V

The number of directors of the corporation may be fixed by the Bylaws, but shall not be less than three (3).
