ARTICLES OF INCORPORATION

The undersigned, acting as incorporators, in order to form a corporation for the purposes hereinafter stated, pursuant to the Idaho Business Corporation Act, do hereby adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation shall be Norab, Inc.

ARTICLE II

The purposes for which said corporation is formed are:

- A. To engage in the business of mining for precious metals including the business of buying, selling and trading in metal stocks as well as the operation of mining claims. To buy or sell all types of securities including stocks, bonds, commodities, options or other types of securities.
- B. The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE III

The Corporation is to have perpetual existence.

ARTICLE IV

The address of the Corporation's initial registered office shall be 2000 Broadway, Idaho Falls, Bonneville County, State of Idaho and the name of its initial registered agent at such address is J. E. Browning.
