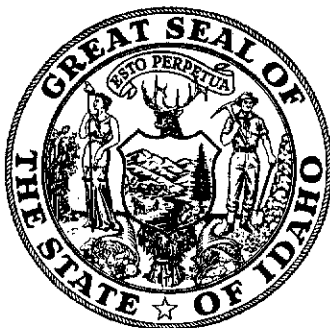




2. It is incorporated under the laws of Michigan


