ARTICLES OF INCORPORATION
OF
McCALL BROADCASTING, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is McCALL BROADCASTING, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: To acquire equipment and licenses necessary for the operation of an AM Broadcast Station; and for any lawful purpose.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is one thousand (1000) shares of common stock, (all without par value).
