



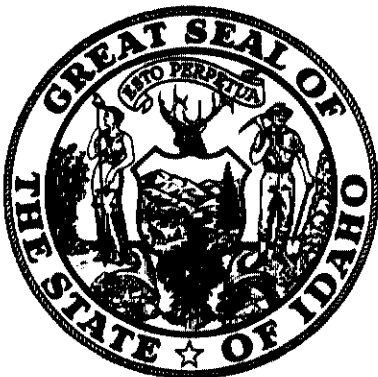
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION
OF
McCALL BROADCASTING, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

- FIRST: The name of the corporation is McCALL BROADCASTING, INC.
- SECOND: The period of its duration is perpetual.
- THIRD: The purpose or purposes for which the corporation is organized are: To acquire equipment and licenses necessary for the operation of an AM Broadcast Station; and for any lawful purpose.
- FOURTH: The aggregate number of shares which the corporation shall have authority to issue is one thousand (1000) shares of common stock, (all without par value).
- FIFTH: The address of the initial registered office of the corporation is 706 N. First, P. O. Box 1318, McCall, Idaho, 83638 and the name of its initial registered agent at such address is Steven J. Millemann.
