ARTICLES OF INCORPORATION

OF

NEAR NU CARS, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, MERLIN FARNES, MERLIN D. FARNES and CHARLES W. ELLER, being persons of full age, residents of the State of Idaho, and citizens of the United States, desiring to form a General Business Corporation under and by virtue of the provisions of Chapter I of Title 30 of the Idaho Code, and we do hereby certify, declare and adopt the following Articles of Incorporation:

I

The name of the Corporation is NEAR NU CARS, Inc.

II

The nature, objects and purposes of this Corporate shall be to do any and all things hereafter set forth to the same extent as natural persons might or could do in any part of the world, namely:

- a. To engage in the business of purchasing, acquiring, owning, leasing, selling, transferring, encumbering, generally dealing in, repairing, renovating, and servicing all types of new and used automobiles, trucks, and other motor vehicles and any parts or accessories used in connection therewith; and the purchasing, acquiring, owning, selling, and generally dealing in all types of supplies used by all types of motor vehicles.
- b. To manage, lease, purchase or otherwise acquire and to hold, own, to sell or dispose of real estate, and do such things in connection therewith as shall be convenient, necessary or required by this corporation in conducting of its business and at such

places as the Board of Director's may determine. c. To borrow money for its corporate purposes, and to make, accept, endorse, executed, and issue promissory notes, bills of exchange, bonds, debentures or other obligations from time to time, for the purpose of purchasing property, or for any other purpose in or about the business of the corporation, and if deemed proper, to secure the payment of any such obligations by mortgage, pledge, deed, trust or otherwise. d. To acquire, and take over as a concern and thereafter to carry on the business of any person, firm or corporation in any business which this corporation is authorized to carry one, and in connection therewith to acquire the good will and all or any of the assets, and to assume or otherwise provide for all or any of the

- liabilities of any such business.
- e. To sell, improve, manage, develop, lease, mortgage, dispose of or otherwise turn to account or deal with all or any part of the property of the Corporation.
- f. To carry on business at any place or places within the jurisdiction of the United States, and in any and all foreign countries, and to purchase, hold, mortgage, convey, lease, or otherwise dispose of same.
- To enter into, make, perform, and carry out contracts of every sort and kind which may be necessary or convenient for the business of the Corporation or business of a similar nature, with any person, firm, corporation, private, public or municipal, body politic or under the government of the United States, or any state, territory or colony thereof or any foreign government, so far as and to the extent that the same may be done and performed by the corporations

that are organized under the General Corporation Law.

h. To do all and everything necessary, suitable or proper for the accomplishment of any of the purposes, the attainment of any of the objects or the furtherance of any of the powers, herein-before set forth, either alone or in connection with other corporations, firms or individuals and either as principals, or agents and to do every other act or acts, thing or things, incidentally, or appurtenant to or growing out of or connected with the aforesaid objects, purposes or powers of any of them.

i. The foregoing enumeration of specific powers of the corporation shall not be deemed to limit or restrict in any manner the general powers of the corporation, and the enjoyment and exercise thereof, as conferred by the laws of the State of Idaho, upon corporations organized under the provisions of Chapter I of Title 30, Idaho Code.

III

This corporation shall have a total authorized capital of Fifty Thousand and no/100 Dollars, divided into 500 shares at the par value of One Hundred and no/100 Dollars per share.

IV

Each of the stockholders of record shall be entitled at all meetings of the corporation and any other matters requiring a vote, to one vote for each share of stock standing in his name upon the books of the corporation. In voting for directors of officers the stock may be voted cumulatively.

V

The office of the corporation shall be located at 3901 Chinden Blvd., Boise, Idaho.

The duration of the corporation is to be perpetual.

VII

The number of directors is to be not less than three or more than seven in number. The directors need not be stockholders.

The shares of stock shall not be transferred in any manner whatsoever unless the holder thereof first offers them to the Corporation at par value.
