ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION  
OF SHERMAN ENTERPRISES, INC.

The following Articles of Amendment were duly adopted by the shareholders of Sherman Enterprises, Inc. at a meeting duly and regularly held:

I.

The name of the corporation is Sherman Enterprises, Inc.

II.

Article 4 of the Articles of Incorporation was hereby amended to read as follows:

4. The corporation shall have the authority to issue 1,000 shares of common stock at no par value.

III.

The date of the adoption of the amendment by the shareholders was October 25, 1992.

IV.

The number of shares of common stock outstanding, and the number of shares of common stock entitled to vote on the amendment, was 1,000. There are no classes or shares of preferred stock issued or outstanding.

V.

The number of shares of common stock voted for such amendment was 1,000, and the number of shares of common stock voted against such amendment was zero.

VI.

The amendment does not provide for an exchange, reclassification or cancellation of issued shares.

VII.

The amendment does not effect a change  
in the amount of stated capital.
