## ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a nonprofit corporation under the Idaho Business Corporation Act, adopt(s) the following Articles of Incorporation for such corporation:

ARTICLE I.

NAME

The name of the nonprofit corporation, the subject of these Articles of Incorporation, is KIWANIS CLUB OF SHELLEY, INC.

ARTICLE II.

The corporation, the subject of Article I above, is a nonprofit corporation incorporated under Section 30-301 of the Idaho Code, as a nonprofit organization, and is a not-for-profit organization that is group exempt from payment of federal income taxes under Section 501(c)(4) of the Internal Revenue Code.

ARTICLE III.

PERIOD OF DURATION

The period of its duration is perpetual.

ARTICLE IV.

PURPOSE OR PURPOSES OF CORPORATION

The purposes of this corporation are:

(a) To give primacy to the human and spiritual rather than to the material values of life.

- (b) To encourage the daily living of the Golden Rule in all human relationships.
- (c) To promote the adoption and the application of higher social, business, and professional standards.
- (d) To develop, by precept and example, a more intelligent, aggressive, and serviceable citizenship.
- (e) To provide through this club, a practical means to form enduring friendships, to render altruistic service, and to build better communities.
- (f) To cooperate in creating and maintaining that sound public opinion and high idealism which make possible the increase of righteousness, justice, patriotism, and good will.
- (g) For the purposes aforesaid, to take over the assets, rights and franchises of the unincorporated club, known as the Kiwanis Club of Shelley, and its members.
- (h) To do all such things as are incidental or conducive to the attainment of the above objects.

#### ARTICLE V.

#### **MEMBERS**

The membership of this corporation shall consist of the individuals elected to membership in the KIWANIS CLUB OF SHELLEY, INC.

#### ARTICLE VI.

#### MANAGEMENT OF ITS AFFAIRS

The management of the affairs of the KIWANIS CLUB OF SHELLEY, INC., shall be vested in its members pursuant to Section 30-314(c), Idaho Code.
