ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF POST FALLS VOLUNTEER FIRE DEPARTMENT, INC.

Pursuant to the provisions of Section 30-327 of the Idaho Nonprofit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST the name of the corporation is POST FALLS VOL-UNTEER FIRE DEPARTMENT, INC.

ARTICLE 1 of the original Articles of Incorporation is amended to read as follows:

ARTICLE 1.

The name of the corporation is the Post Falls Ambulance and Rescue, Inc. The principal place of business is at 417 Fredrick, Post Falls, Kootenai County, Idaho.

ARTICLE 4 of the original Articles of Incorporation is amended to read as follows:

ARTICLE 4.

The management of the corporation shall be vested in the Board of Directors which shall consist of not less than three (3) directors. The total number of directors shall be set by the Bylaws.

ARTICLE 5 of the original Articles of Incorporation is amended to read as follows:

ARTICLE 5.

The purposes of this organization shall be to provide emergency medical services for the sick and injured and to provide emergency extrication and other emergency services as determined by the membership.

ARTICLE 7 of the original Articles of Incorporation is amended to read as follows:

ARTICLE 7.

Active membership in this organization shall be granted to all persons who make application to join and are approved by a two-thirds (2/3) vote of the members present at any regular monthly meeting.
