ARTICLES OF INCORPORATION), OF STATE IDAHO GOLD AND SILVER COIN CORPORATION

I. NAME

The name of the corporation is IDAHO GOLD AND SILVER COIN CORPORATION.

II. DURATION

The period of duration of the corporation will be perpetual.
