#### **ARTICLES OF INCORPORATION**

The undersigned, acting as incorporators of a corporation under the Idaho Nonprofit Corporation Act, adopt the following articles of incorporation:

### ARTICLE I NAME OF THE CORPORATION

The name of the corporation is the Tennessee Walking Horse Club of Southwest Idaho, Inc. ("Corporation").
