## 1 ARTICLES OF INCORPORATION 2 of 3 MIGHTY MART, INC. 4 KNOW ALL MEN BY THESE PRESENTS: That we, the under-5 6 signed, at least two-thirds of whom are residents of the United 7 States, and of full age, have this day voluntarily associated our-8 selves together for the purpose of forming a corporation under the 9 laws of the State of Idaho, and we hereby certify in writing: 10 I. 11 The name of said corporation shall be MIGHTY 12 MART, INC. 13 II. 14 The objects and purposes for which the corporation is formed are to operate a general grocery, market, merchandising 15 16 and variety business in all its branches, wholesale and retail, and to conduct all lines of business in connection with or incidental 17 18 to any of the foregoing; and in connection with any of the fore-19 going to acquire, lease, own, handle, improve, and to mortgage, 20 pledge or otherwise encumber, sell, contract to sell, or lease or otherwise dispose of any and all types of real and personal property; 21 22 to own, vote, sell, pledge or otherwise dispose of and deal in the 23 shares of this corporation or any other corporation; to do any and 24 all things that may be necessary or pertinent or expedient in con-25 nection with or to accomplish any of the foregoing objectives; and 26 to do all acts permitted by the foregoing and by I.C. 30-114, and all 27 laws amendatory thereof of supplemental thereto. 28 TIT. 29 The registered office and place where the principal 30 business of said corporation is to be transacted is at the office

of the company in Lewiston, Nez Perce County, Idaho.

1 The duration of this corporation and the term of its 2 3 existence is perpetual. V. 4 The number of directors of said corporation shall be 5 The number of directors may be increased by the share-6 holders at any regular meeting or any any special meeting of which 7 notice of such purpose is given. If the number of directors be more 8 , the said number may be decreased by the share-9 holders at any regular meeting or any special meeting at which 10 notice of such purpose is given. A director shall hold office for 11 the term for which he was named or elected, or until his successor 12 is elected and qualified. 13 VI. 14 The total authorized shares of the capital stock of 15 said corporation is 500 shares of the par value of \$100.00 per share, 16 making a total authorized capital of \$50,000.00. Each share 17 entitles its holder to one vote without preference; the stock shall 18 be common stock and shall be non-assessable. 19 VII. 20 The power to repeal and amend the By-Laws and adopt 21 new By-Laws is hereby conferred upon the directors by their majoritly 22 The directors shall not make or alter any By-Laws fixing 23 their qualifications, classifications, term of office or compensa-24 tion. The board of directors shall be, and they hereby are, 25 authorized to determine the value of any property or considerations, 26 other than money, which is offered, tendered or paid for corporate 27 stock. 28
