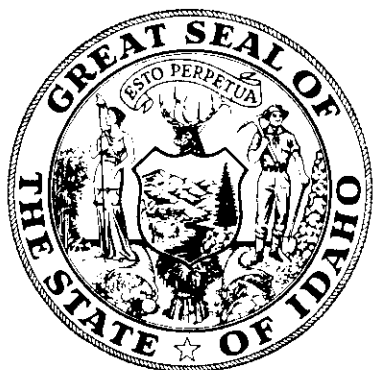

ARTICLES OF INCORPORATION
OF
T & J ENTERPRISES, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is T & J ENTERPRISES, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purposes for which the corporation is organized are to promote and provide public and private entertainment events, together with all related activities and the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 5,000 shares, with a par value of \$10.00 per share.

FIFTH: There are no provisions denying pre-emptive rights.

SIXTH: The internal affairs of the corporation shall be governed by a duly adopted Code of Bylaws which shall be consistent with these Articles of Incorporation and the laws of the State of Idaho.

SEVENTH: The address of the initial registered office of the corporation is P. O. Box 1147, Sandpoint, Idaho 83864, (the physical location being 3/8 of a mile from the State Highway on County Road, being upon Main Street, north of Second Street, in Town of Kootenai, County of Bonner, State of Idaho), and the name of the registered agent at such address
