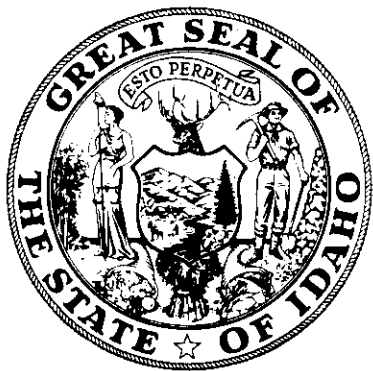

KNOW ALL MEN BY THESE PRESENTS:

The Undersigned, acting as incorporators under the Idaho Business Corporation Act, adopt the following Articles of Incorporation:

SECTION ONE:

The name of the corporation is PLANTATION SNO, INC.

SECTION TWO:

The period of its duration is perpetual.

SECTION THREE: CORPORATE PURPOSES:

To operate food concessions; to buy, sell, and deal in food products, confectioneries, soft drinks, and other articles and products customarily dealt in by food concessionaires; to carry on any trade or business incidental thereto or connected therewith; and to own, rent, lease, sell, or otherwise manage, control, deal in or dispose of any and all property, real or personal, of every description, incidental to or capable of being used in connection with such trade or business.

To buy, or otherwise acquire, manufacture, market, prepare for market, sell, deal in, and deal with, import, and export food and food products of every class and description, fresh, canned, preserved, or otherwise; and, to prepare and serve all food, beverages and other preparations and refreshments of all kinds.

To purchase, receive by way of gift, subscribe for, invest in, and in all other ways acquire, import, lease, possess, maintain, handle on consignment, own, hold for investment or otherwise, use, enjoy, exercise, operate, manage, conduct, perform, make, borrow, guarantee, contract in respect of, trade and, deal in, sell, exchange, let, lend, export, mortgage, pledge, deed in trust, hypothecate, encumber, transfer, assign and in all other ways dispose of, design, develop, invest, improve, equip, repair, alter, fabricate, assemble, build, construct, operate, manufacture, plant, cultivate, produce, market and in all other ways (whether like or unlike any of the foregoing), deal in and with property of every kind and character, real, personal, or mixed, tangible or intangible, wherever situated and however held, including, but not limited to, money, credits, choses in action,

securities, stocks, bonds, warrants, script, certificates, debentures, mortgages, notes, commercial paper, and other obligations and evidences of interest in or indebtedness of any person, firm or corporation, foreign or domestic, or of any government or subdivision or agency thereof, documents of title, and the accompanying rights, and every other kind and character of personal property, real property (improved or unimproved), and the products or avails thereof, and to every character of interest therein and appurtenance thereto, including, but not limited to, mineral, oil, gas, any water rights, all or any part of any business and its incidents, franchises, subsidies, concessions, grants, rights, powers, or privileges, granted or conferred by any government or subdivision or agency thereof, and any interest in or part of any of the foregoing, and to exercise in respect thereof all of the rights, powers, privileges, and immunities of individual owners or holders thereof.

To carry on any business whatsoever that this corporation may deem proper or convenient in connection with any of the foregoing purposes or otherwise, or that it may deem calculated, directly or indirectly, to improve the interests of this corporation, and to have and to exercise all powers conferred by the laws of the State of Idaho on corporations formed under the laws pursuant to which and under which this corporation is formed, as such laws are now in effect or may at any time hereafter be amended, and to do any and all things hereinabove set forth to the same extent and as fully as natural persons might or could do, either alone or in connection with other persons, firms, associations, or corporations, in any part of the world.

SECTION 4: STOCK:

The aggregate number of shares which the corporation shall have authority to issue is 3000 shares of common stock at the part value of \$1.00 per share.

SECTION 5: CORPORATION REGULATIONS:

The internal affairs of PLANTATION SNO, INC., shall be regulated by such by-laws as may be provided for the corporation and in addition shall be regulated in accordance with the provisions of the Idaho Business Corporation Act, Section 30-1-23(A).

SECTION 6: REGISTERED OFFICE:

The address of the initial registered office of PLANTATION SNO, INC., is 1350 Yellowstone Avenue, Pocatello, Idaho, and the name of its initial registered agent is MARVIN G. BEESLEY.

SECTION 7: CORPORATE DIRECTORS:




