The undersigned, desiring to act as a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such Corporation:

FIRST: The name of the Corporation is:

Crawford's Pest Control, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The Purpose or purposes for which the corporation is organized is the transaction of any or all lawful businesses for which corporations may be incorporated under the Idaho Business Corporation Act, including the conduct of a residential, commercial, and municipal pest control and spraying business.

FOURTH: The total authorized stock of this corporation shall be divided into 100 shares of a single class, all of which shall be without nominal or par value.

FIFTH: There are no provisions denying preemptive rights.

SIXTH: There are no provisions for the regulation of the international affairs of the corporation.


