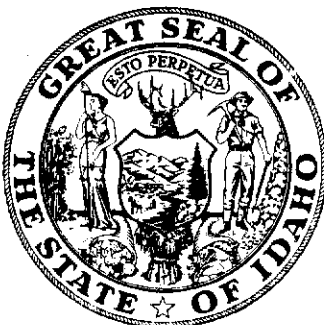

ARTICLES OF INCORPORATION

OF

KNOW ALL MEN BY THESE PRESENTS, that FRED R. MURPHY and SUSAN L. MURPHY, husband and wife, the undersigned, full-age citizens of the United States, this day, for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, do hereby certify:

ARTICLE I.

That the name of the corporation shall be MURPHY MARINE CONSTRUCTION CO., an Idaho corporation.

ARTICLE II.

The purposes for which the corporation is organized shall be, and include, the transaction of any and all lawful business for which a corporation may be incorporated under "The Idaho Business Corporation Act."

ARTICLE III.

This corporation shall have perpetual existence.

ARTICLE IV.

The location and post office address of the registered office in this State and principal place of business shall be West 98 Kidd Island Bay Road, Coeur d'Alene, Kootenai County, Idaho 83814, and the initial registered agent at such address is SUSAN L. MURPHY.

ARTICLE V.

There shall be only one class of capital stock of this corporation, which shall be designated as common stock, and such common stock shall be and consist of ONE HUNDRED THOUSAND (100,000) shares, with no par value.

ARTICLE VI.

The number of directors constituting the initial Board of Directors of the corporation shall be two (2). The number of directors and officers may from time to time be fixed by the bylaws of the corporation at any number.

ARTICLE VIII.




necessary and convenient, providing the same are not out of harmony with the laws of the State of Idaho, or these Articles of Incorporation.




