NOW, THEREFORE:

1. The Court, having previously found on August 14, 2012, that grounds existed for dissolution of Parker Enterprises, Inc. pursuant to Idaho Code §30-1-1430(2)(b); and having further found on the date of this order that all creditors have been paid except the plaintiff, Wesley A. Wilkinson, and that the amount of his judgment exceeds the value of the assets of the corporation and thus said corporation is insolvent; and therefore,

2. The Court does hereby decree the dissolution of Parker Enterprises, Inc. pursuant to Idaho Code Section 30-1-1430, effective as of the date of this order.
