ARTICLES OF INCORPORATION

OF

BLACKFOOT REMINDER, INC.

KNOW ALL MEN BY THESE PRESENTS: That We, the undersigned, being natural persons of full age, and citizens of the United States of America, have, this day, voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify:

ARTICLE I.

That the name of said corporation shall be BLACKFOOT REMINDER, INC., with its principal place of business at Blackfoot, County of Bingham, State of Idaho.

ARTICLE II.

That the corporation shall have perpetual existence.

ARTICLE III.

That the purposes for which the corporation is formed are:

- 1) The primary purpose of said corporation is to engage in commercial printing and publications.
- 2) To acquire, own, lease, rent and operate all necessary machinery and equipment needed to operate a commercial printing establishment, including presses and all other types of equipment and paraphernalia incident to the operation of a commercial printing establishment, including selling advertising and printing

a publication containing said advertising, together with current news items.

- 3) To purchase or otherwise acquire, own, hold, lease, sell, exchange, assign, transfer mortgage or otherwise dispose of or hypothicate real estate and/or personal property and any interest in and to real estate and/or personal property.
- 4) To buy, sell, make, deliver and/or negotiate promissory notes, drafts, contracts of sale, bills of exchange, and other evidences of debt and/or evidences of ownership.
- 5) To purchase, own, hold, buy and sell stocks of other corporations and/or bonds of every type and nature.
- 6) To enter into any kind of contract or agreement, cooperative or profit-sharing plan with its officers and/or employees that the corporation may deem advantageous or expedient or otherwise beneficial or desirous to reward or pay such persons for their services.
- 7) To purchase, lease, or otherwise acquire, in whole or in part, the business good will, rights, franchises and property of every kind and nature, and to undertake the whole or any part of the assets and liabilities of any kind, and to pay for the same in cash, or in the stock of this corporation, or otherwise; to hold or in any manner dispose of the whole or any part of the business or property so acquired, and to exercise all the powers necessary or incidental to the conduct of such business.
- 8) To borrow money and to issue bonds, debentures, notes, and other obligations of this corporation from time to time for any lawful objects or purposes of this corporation, and

to mortgage, pledge, hypothicate, and/or convey in trust any or all of its property to secure the payments thereof, and said corporation is specifically authorized to borrow money from any of its stockholders and/or officers, and to loan money to any of its stockholders and/or members.

9) To enter into, make, perform and carry out contracts of every kind and for any lawful purpose, without limit as to amount, with any person, State or Government, or any subdivision, district or department thereof.

10) To engage in any type of lawful business including but not exclusive to commercial printing.

#### ARTICLE IV.

That the location and post office address of the registered office of the corporation is Blackfoot, Idaho.

#### ARTICLE V.

That this corporation is authorized to issue 500 shares of No Par Value Stock.

#### ARTICLE VI.
