



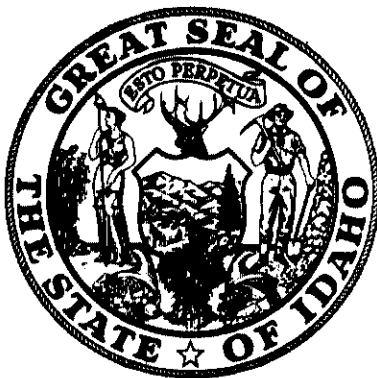
CERTIFICATE OF INCORPORATION

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is NIAGARA ENTERPRISES, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which the corporation is organized is to transact any and all lawful business for which corporations may be incorporated within and under the Idaho Business Corporations Act.

FOURTH: The corporation shall have authority to issue one thousand (1000) shares, all of one class, having no par value.

FIFTH: The address of the original registered office of the corporation is 1911 Niagara, Idaho Falls, Idaho 83404. The name of its initial registered agent at such address is Devon Ivie.

SIXTH: The number of directors constituting the initial Board of Directors of the corporation is two (2), and






