ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is IVOCAD Systems, Inc.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose or purposes for which the corporation is organized are: the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

The corporation is authorized to issue only one class of stock, and all issued stock shall be held by record by not more than three (3) persons. Stock shall be issued and transferable only to natural persons who are not non-resident aliens.

ARTICLE V

The aggregate number of shares which the corporation shall have authority to issue is 6,000, \$1.00 par value.

ARTICLE VI

There are no provisions denying preemptive rights.

ARTICLE VII

Provisions for the regulation of the internal affairs of the corporation are the By-Laws of the corporation.

ARTICLE VIII

The address of the initial registered office of the corporation is 2025 Harrison Blvd., Boise, Idaho, and the name of its initial registered agent at such address is S. Kyle Foldyna, aka S. Kyle Hamilton.

ARTICLE IX

The number of directors constituting the initial board of directors of the corporation is one, and the name and address of the person who is to serve as director until the first annual meeting of shareholders or until a successor is elected and shall qualify is:


