ARTICLES OF INCORPORATION  
OF  
BESTWAY ENTERPRISES, INC.

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, all being citizens of the United States of legal age, this day having voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, do hereby certify:

ARTICLE I.  
Name

The name of the corporation shall be "BESTWAY ENTERPRISES, INC."

ARTICLE II.  
Purpose

The purpose or purposes for which the corporation is organized are: the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE III.  
Duration

The period of existence and the duration of the life of this corporation shall be perpetual.

ARTICLE IV.  
Place of Business

The address of the initial registered office of the corporation is 1004 South Midland, Nampa, Canyon County, State of Idaho and the name of the initial registered agent of the corporation is DANNY DUANE GUNTRUM, SR.
