The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

I. NAME

The name of the corporation is WARREN RIVER EXPEDITIONS, INCORPORATED.

II. DURATION

The period of its duration is perpetual.

III. PURPOSES

The purpose or purposes for which this corporation is organized are for providing float trips, outfitting and guide services; and the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
