

ARTICLES OF AMENDMENT
OF
GARRETT FREIGHTLINES, INC.

Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, Garrett Freightlines, Inc., an Idaho corporation ("the corporation"), adopts the following Articles of Amendment of its Articles of Incorporation:

1. Articles III and V of the Articles of Incorporation of the corporation are amended to read as follows:

ARTICLE III

The principal office of the corporation shall be at such place within or without the State of Idaho as the Board of Directors may, from time to time, determine.

ARTICLE V

The number of Directors of said corporation shall be fixed by the by-laws of the corporation.

2. The aforesaid amendment was adopted by the sole stockholder of the corporation as of June 22, 1982, in the manner prescribed by laws of the State of Idaho.

3. The number of shares of the corporation authorized to vote and outstanding at the time aforesaid amendment was adopted was Seven Hundred and Sixty-Eight (768) shares. The number of shares voting for adoption of said amendment was Seven Hundred and Sixty-Eight (768) shares.
