2. Except as specifically amended herein, each and every provision and term of the Articles of Incorporation of Bigwood Condominiums No. 3 Association, Inc., is ratified and confirmed and shall remain in full force and effect.

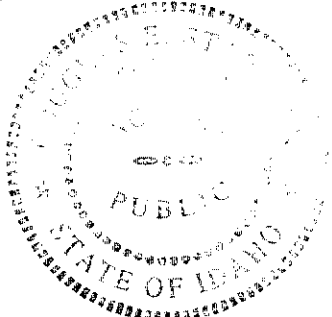

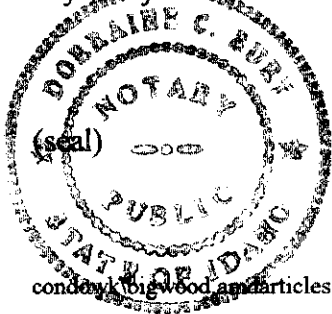
