ARTICLE I

The name of this Non-Profit Corporation shall be THE POCATELLO ART CENTER., Inc.

ARTICLE II

The specific and primary purposes for which the Non-Profit Corporation is formed are:

- 1. To foster, promote, develop and encourage education and knowledge and the dissimilation of the same to all persons located in the State of Idaho or elsewhere as to the skills and appreciation of the mental and physical invalue in the arts.
- 2. The purpose is the encourage, develop, promote, sponsor and foster an appreciation of ones own response to the arts, the individuals development in all aspects of the arts.
- 3. These purposes shall not be for the protection, promotion or stimulation of any business organized for profit and not for participation in any political campaign for or against any candidate for public office.
- 4. This corporation is for the use of charitable and educational purposes and by producing information and spreading information and skills concerning all the arts including all forms of appreciation.

ARTICLE III

The principal office or place of business of the corporation is to be located at: 401 1/2 North Main, Pocatello, Idaho 83204.

The registered agent is Barbara Ruffridge, 659 W. Chubbuck, Chubbuck, Idaho 83202.

ARTICE IV

Participation in the Corporation shall be by membership and no capital stock shall be issued. Members may be classified into different groups, but each member shall have an equal interest in the Corporation. The By-laws

of the Corporation shall set out the method by which membership in the Corporation shall be acquired, and the form of membership certicates. No membership certificate may be assigned so that the transferror thereof becomes a member of the Corporation except by resolution of the Board of Directors.

ARTICLE V

The period for the duration and existence of the Corporation is perpetual.

ARTICLE VI

The main part of the activities of the Corporation shall be to spread information by the providing space to show, demonstrate and acquire skills concerning all the arts. Also the secure such space by purchase or through gift. Also to construct, buy or sell real or personal property to achieve such purposes.

ARTICLE VII

The Board of Directors shall consist of no less than three members.

The number of any additional members of the Board of Directors shall be specified in the By-laws of the Corporation. ARTICLE VIII

No part of the income of the Corporation shall injure to the benefit of any member, trustee, director, officer of the Corporation or any private individual, except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one or more of its purposes.

ARTICLE IX

In the event of dissolution of the Corporation, no member, director, officer or contributor shall be entitled to any distribution or division of the remaining property or its proceeds, and the balance of all money and other property received by the Corporation from any source, after the payment of all debts and obligations of the Corporation, shall be used or distributed exclusively to a non-profit fund, foundation or corporation which has established its tax exempt status under S501 (c) (3) of the Internal Revenue Codes, as the same now exists or as it may be amended from time to time.

ARTICLE X

The Corporation shall have all powers granted nonprofit corporations under the laws of the State of Idaho; however, notwithstanding anything contained herein to the contrary, this Corporation shall exercise only such powers as are in furtherance of the exempt purposes of organization set forth in S501 (c) (3) of the Internal Revenue Code under which the Corporation chooses to qualify for exemption as the same now exists or as it may be amended from time to time.

ARTICLE XI

At any meeting of the membership, 25% percent of the members voting in person or by proxy shall constitute a quorum for the transaction of all business properly before the said meeting.
