## ARTICLES OF INCORPORATION

OF

## NORTHWESTERN STAGE LINES, INC.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all of whom are citizens of the United States of America, and of legal age, have today voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we hereby certify:

I.

The name of said corporation shall be "NORTHWESTERN STAGE LINES, INC."

II.

The purposes for which this corporation is formed are:

(a) To engage in the business of transporting persons and property from place to place other than by rail or water in the State of Idaho and elsewhere in the United States, in intrastate, interstate and foreign commerce; and to operate and control transportation terminal facilities; to own acquire, lease, manage, and operate motor vehicles, stages, coaches, buses, trucks and other conveyances of every kind and description for the transportation of persons and property, and all machinery, appliances, tools and implements of any and every character and description necessary, proper or convenient in connection with the business of this corporation. To obtain franchises, permits, certificates and such other permission as may be necessary or convenient for the operation of its business, and to operate motor vehicles and other conveyances as a common carrier between fixed termini or over regular routes, as well as on contract or for special occasions, and to engage in the business of conducting and operating sightseeing tours and expeditions, and to acquire by purchase, lease, gift, devise or otherwise, and to manage, control and operate suitable stations, garages, warehouses, filling stations, and other necessary or

convenient transportation and terminal facilities. To acquire by purchase or otherwise any and all real estate necessary or convenient for the operation of the business of this corporation with the buildings and structures thereon, sufficient for shops, repair shops, filling stations, and garages and to maintain and operate such shops, repair shops, filling stations and garages for the purpose of making, manufacturing, building and repairing automobiles, stages, coaches, trucks and vehicles of every kind and nature, and to purchase, lease, exchange or otherwise acquire such lands and property of every kind and description as may be necessary or convenient in connection with the business of this corporation, and to sell or exchange any or all of the rights or privileges owned by it or in which it has any interest.

- (b) To purchase, lease or otherwise acquire, and to operate and manage hotels, restaurants, lunch counters, soda fountains, soft drink parlors, tobacco stands, magazine stores and stores and shops of every kind and description; to enter into contracts of every kind and nature pertaining to the operation of the same or to any of the operations pertaining to the business of this corporation, whether said operations be by this corporation or by others as tenants, lessees, or joint adventurers with this corporation. To give and lease concessions for the operation thereof to any other person, firm or corporation; to buy, lease or otherwise acquire automobiles, stages, coaches, trucks and vehicles of every kind and description, and to sell, lease or otherwise dispose of the same, and to act as agent or broker for any firm, corporation or person engaged in the business of manufacturing, selling or dealing in automobiles, stages, trucks, motor vehicles or other means of conveyance. To engage in the business of operating garages, repair shops and factories of every kind and nature and to sell and dispose of the same or of any product manufactured by this corporation.
- (c) To subscribe for, acquire or hold, and to sell or otherwise dispose of stock in this or any other corporation. To borrow and lend money, and to execute and receive such notes, bonds, mortgages, warrants or other

obligations and securities as may be necessary, convenient or proper in connection with the business of this corporation. To buy, lease or otherwise acquire, and to sell, exchange and otherwise deal in or dispose of, either as principal or agent, real estate and personal property of every kind and description. To act as agent or representative of corporations, firms or individuals. To rent, lease, own and control all necessary buildings and rooms for carrying on the business of this corporation, and to do and perform every act and thing necessary to properly carry out and conduct the business of this corporation.

- (d) To aid in any manner any corporation whose stock, bonds or other obligations are held or are in any manner guaranteed by this corporation, and to do any other acts or things for the preservation, protection, improvement or enhancement of the value of any such stock, bonds or other obligations, or to do any other acts or things designed for such purpose.
- (e) To purchase, hold, sell and reissue the shares of its own capital stock.
- (f) To buy, lease or otherwise acquire so far as may be permitted by law the whole or any part of the business, good will and assets of any person, firm, association or corporation engaged in a business of the same general character as that for which this corporation is organized.
- (g) To have the powers and to do those acts, things and deeds set forth in Section 29-114, Idaho Code Annotated, 1932, and any and all amendments thereto.
- (h) To do all acts and things necessary to carry out the purposes and intent expressed in the above provisions, it being the express intent that the said corporation shall be able to do all acts and things necessary and proper in conducting and carrying on the business of a motor carrier of persons and property and all types and kinds of businesses incidental thereto.

The location and post office address of the registered office of the corporation is 1112 Grove Street, Boise, Ada County, Idaho.

IV.

The capital stock of the corporation is One Hundred Fifty
Thousand Dollars (\$150,000.00) divided into Fifteen Hundred (1,500) shares
of common stock of the par value of One Hundred Dollars (\$100.00) per
share. All of the stock shall have the same powers and voting rights and
shall be non-assessable for any purpose whatsoever.

٧.

The term for which the corporation shall exist is perpetual.

VI.

The number of directors of said corporation shall be three (3), none of whom need be shareholders in said corporation.

VII..

In addition to the powers granted by the laws of the State of Idaho, these articles of incorporation, and the by-laws of said corporation, the Board of Directors shall also have power, without the assent or vote of the stockholders, to fix the times for the declaration and payment of dividends, to fix and vary the amount to be reserved as working capital of the corporation, to authorize and cause to be executed mortgages and liens upon all the property of the corporation or any part thereof, and to fix the salary and compensation for services to be paid to all officers and employees of the corporation.
