



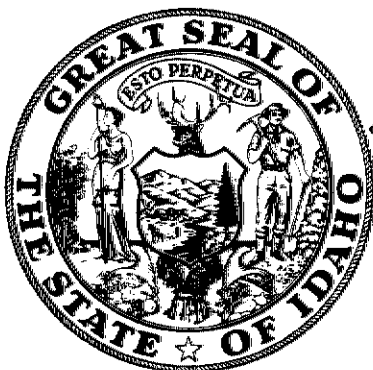
**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

WE the undersigned natural persons of age twenty-one or more do hereby adopt the following Articles of Incorporation:

ARTICLE I

NAME

The name of this non-profit corporation is Parents Alliance for Children and Teachers, Inc.

ARTICLE II

STATUS

The corporation is a non-profit corporation.

ARTICLE III

AUTHORIZATION

This corporation shall proceed under Title 30, Chapter 300, Idaho Code, the "Idaho Non-Profit Organization Act", of the laws of the State of Idaho.

ARTICLE VI

PURPOSE

The purpose for which this corporation is organized shall be to promote the welfare of children and youth in school and community, to secure adequate laws for the care and protection of children and youth; to bring into closer relations the home and the school so that parents and teachers may cooperate intelligently in the training of the children; and to develop between educators and the general public such united efforts as will secure for every child the highest advantages in physical, mental and social education.

ARTICLE V

PLACE OF BUSINESS

The registered agent of this corporation is hereby designated as: Jan Hobbs, President of this Corporation, c/o Big Valley School, 202 18th Street, Rupert, Idaho, which address is the business office of the registered agent designated as above set forth.

ARTICLE VI

DURATION

The period of duration of this corporation is perpetual.

ARTICLE VII

NON-STOCK CORPORATION

This corporation shall be non-stock, and no dividends or pecuniary profits shall be declared or paid to the members thereof.

ARTICLE VIII

The number of directors constituting the initial board of directors of the corporation is four and the names and addresses are as follows:

ARTICLE IX

NOMINATING COMMITTEE

Names for officers are submitted of parties who will volunteer to take the offices.

ARTICLE X

ELECTION OF DIRECTORS

The directors are the same as the officers and are elected as directed in Article IX.

ARTICLE XI

CORPORATE OFFICERS

The general officers of the Foundation shall be President, Vice-President, Secretary and Treasurer.

ARTICLE XII

ELECTION OF OFFICERS

The officers shall be elected as follows: The Vice-President shall automatically succeed to the office of President. The other candidates will be submitted by the nominating committee and elected by majority voice vote. The term of an elected officer shall run from May 1st to May 1st of the following year.

ARTICLE XIII

MEMBERSHIP REQUIREMENTS

The methods and conditions on which members shall be accepted transferred, discharged and removed shall be as follows: Any individual who subscribes to the objects and basic policies of this corporation and is either a teacher or the parent or guardian of a student attending Big Valley School in Rupert, Idaho, may become a member.

ARTICLE XIV

AMENDMENTS

These Articles may be amended in the manner provided by statute at the time of amendment.
