ARTICLES OF INCORPORATION  
OF APR 24 8 57 AM '81  
ELMORE UNITED METHODIST CHURCH, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Nonprofit Corporation Act, Idaho Code, Chapter 3, Title 30, adopt the following Articles of Incorporation for such corporation:

FIRST - NAME OF CORPORATION: The name of the corporation is Elmore United Methodist Church, Inc..

SECOND - NONPROFIT CORPORATION: The corporation is and shall be nonprofit. No part of the corporation's income is to be devoted to other than the purposes hereinafter set forth. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501 (c)(3) of the Internal Revenue Code.

THIRD - DURATION: The duration of this corporation shall be perpetual.

FOURTH - PURPOSE: The purpose of the corporation is primarily and exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code.

In furtherance of its corporate purposes, the corporation shall have all the general and specific powers enumerated in Section 307 of the Nonprofit Corporations Law.

FIFTH - MEMBERSHIP: This corporation is not organized for profit and shall have no capital stock and shall be composed of members rather than shareholders.

SIXTH - GOVERNMENT: The government of this corporation shall be as stated in its by-laws, which shall be adopted by the first directors of this corporation. The by-laws shall be the Book of Discipline of the United Methodist Church as it may be revised or

amended by General Conference of the United Methodist Church.

SEVENTH - REGISTERED OFFICE AND AGENT: The street address of the initial registered office is Route 1, Box 88, Potlatch, Idaho 83855. The initial registered agent at the above address is Roger B. Brown.

EIGHTH - DISSOLUTION: Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a non-profit fund, foundation or corporation which has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code.

NINTH - BOARD OF DIRECTORS: The number of directors constituting the initial board of directors is eight (8), and the names and addresses of the persons who are to serve as directors until the first annual meeting of members or until their successors are elected and shall qualify according to the by-laws, are:
