CERTIFICATE AMENDING

ARTICLES OF INCORPORATION

OF

YREKA UNITED, INC.

We certify to the following:

- 1. A special annual meeting of the shareholders of YREKA UNITED, INC., a corporation organized and existing under the laws of the State of Idaho, maintaining its principal place of business at Kellogg, Idaho, was held on the 5th day of December, 1984, at the hour of 10:00 A.M. (PDT) at the North Shore Motor Hotel, North Shore Plaza, Coeur d'Alene, Idaho. Said meeting was recessed until the 21st day of December, 1984, at 3:00 P.M. (PST) at the same location.
- 2. Notice of said meeting and its purposes were given, in the time and manner required by law, to each shareholder of said company entitled to vote at said meeting.
- 3. At the time of said meeting the capital stock of the company was \$750,000 divided into 7,500,000 nonassessable common shares of the par value of \$0.10 per share, of which 6,771,277 shares were issued and outstanding.
- 4. 4,823,948 of said shares were represented at said meeting in person or by proxy.
- 5. Article III of the Articles of Incorporation of Yreka United, Inc. was duly amended to read as follows:

"III.

That the amount of capital stock is \$2,000,000 divided into 20,000,000 common shares having a par value of \$0.10 per share, all of which shall be nonassessable and without pre-emptive rights of any kind."

4,721,164 shares were voted in favor of said amendment and 82,784 shares were voted against said amendment.
